Types of personal information collected

Data collected automatically

When you visit <https://www.gfintegrale.com/>, we automatically collect information about your device and your interaction with our site via the Google Analytics tool.

This includes the following data:

- IP Address
- Location
- Hardware and software details
- Content the user views on our site
- Links a user clicks on while visiting the site

Personal data not collected automatically

Your personal data is collected via :

- Contact form

This includes the following data:

- Name
- E-mail address
- Phone number

Use of personal information collected

Please note that we only collect data that helps us achieve the purpose stated in this privacy policy. We will not collect any additional data without informing you first.

We use this data to:

- Send promotional offers and targeted communications
- Perform statistical analyses to improve the site
- As part of a data security protocol

Safety measures

Your data is stored in a secure, controlled environment. We use SSL protocols and robust security measures to prevent unauthorized access.

We will not sell or share your data with third parties except as required by law or in the event of legal proceedings.

We may disclose to any member of our organization such user data as they reasonably require to carry out the purposes set out in this policy.

International transfer

User data may be consulted, processed or collected in the following countries:

- Canada

Duration of use of personal data

We store personal data for a period of 5 years. We will ensure that users are notified if their data is stored for longer than this period.

In the event of a data leak

In the event of a leak of your personal data, we undertake to keep you and the *Commission d'Accès à l'Information du Québec* informed.

Your rights

User rights

If you are a resident of Quebec, in accordance with Bill 25, you have specific rights regarding your personal data:

- Right to be informed
- Right of access
- Right to rectification
- Right to data portability

You have the right to object to the use of your data and to withdraw it.
